NOTES TO ASSIST WITH COMPLETION OF THE APPLICATION

- All foals must be in possession of a passport within 6 months of the date of birth or by 30th November of the year of birth, whichever is the latest. If a passport is requested after this time the owner must pay £50.00 to the Suffolk Horse Society and the foal will be registered as 'not for human consumption'.
- If you are not a fully paid-up member of the Suffolk Horse Society, the Society will charge £100 for administration and to pay for the costs of blood DNA.
- If you are registering a Part Bred foal, the Society will charge £50.00 for a passport and an extra £50.00 if you wish for DNA confirmation.
- A blood sample for a Suffolk foal must be taken by the veterinary surgeon at the time of identification completion and must be sent to Weatherbys.
- The foal's full name should be shown as you wish it to be formally registered and to be recorded within the passport i.e. complete with prefix / affix etc.
- The foal's sire and dam names & registration numbers should also be given in full, to ensure correct registration.
- As required by DEFRA, a covering certificate must accompany this application. The covering certificate should have been supplied to you by the stallion owner at the time of covering. If you have not been given this certificate, please contact the stallion owner for the certificate, prior to submitting this application for registration.
- In respect of the Section I forms which are to be completed by the veterinary surgeon, the Society reserves the right to return incorrectly completed forms for replacement.
